



XIV Open Masters Swimming Championship of Baltic States AMBER CUP 2024

REGULATIONS

Objective	To establish the best swimmers and clubs in category of Masters of Baltic region.

Championship time	Competition will be held on the 09-10th March 2024 Registration 09.03.2024 - 14:00 09.03.2024. Warm up - 15:30, Start - 16:00 10.03.2024. Warm up - 9:30, Start - 10:00			
Championship arrangement	The championship is arranged by the swimming club "KOBRAS" in collaboration with Latvian swimming federation (LPF), Education, Culture, and Sports Department of Riga City Council, BJBS „Rīga” and „Sporta nams "Daugava"". The championship is held in accordance with World Aquatics rules for swimming Masters competitions, LPF rules and championship regulations.			
Participants	Swimming Masters from 25 years, as well as any swimming enthusiast starting with 18 years as the age group "0". All participants have to be registered members of World Aquatics approved national federation member teams, clubs or region sportsman (with a valid Masters license). A team is to be represented by not more than 10 swimmers. Two individual event points (the highest scores), obtained applying the newest DSV Master Performance Table, will be summed up for the best swimmers scoring. The following calculation approach is applied for team scoring: <ul style="list-style-type: none"> ○ Individual event participant gains 10 points for the 1st place (in accordance with DSV Master Performance Table 2016); 9 points for the 2nd place; 8 points for the 3rd place; 7 points for the 4th place; 6 points for the 5th; 5 points - for the 6th; 4 points - for the 7th; 3 points - for the 8th; 2 points - for the 9th; 1 point – for the 10th. ○ Team relays: the 1st place – 20 p.; the 2nd – 18 p.; the 3rd – 16 p.; the 4th - 14 p.; the 5th - 12 p.; the 6th - 10 p.; the 7th - 8 p.; the 8th - 6 p.; the 9th – 4 p.; the 10th – 2 p. ○ Two best performed events will be chosen for the team scoring. ○ In case of equal team scoring, the team with higher place in the group has higher overall place. Each participant is personally responsible for his/her own health.

<p>Registration</p>	<p>Final Entries should be submitted using the Online Entry System that can be found following the link: https://www.swimrankings.net/manager/ or submitting filled application form in .xls format (refer to attachment).</p> <p>Technical entry summary (.pdf formatted from Online Entry System) together with relay named list is to be sent to kobras2022@inbox.lv up to the 01th March 2024 , 23:59 indicating the following information:</p> <ul style="list-style-type: none"> ○ Competition name; ○ Club name. <p>After the deadline the registration is closed.</p> <p>If it's necessary the final changes in entry needs to be sent till 04th March 2024, 19:59 to email address: kobras2022@inbox.lv.</p> <p>Each participant is responsible for his/her own health, and confirms it by submission the registration form.</p> <p>One hour before the session start is the last chance to submit team relay participant list – name, surname, year of birth and relay team age group – to competition secretary staff.</p> <p>A change for applied events will be accepted from a team representative person, in case of illness of a participant, latest one hour before the competition start.</p>	

Awarding	<p>The first, the second and the third places are awarded in individual events with the respective medals in each age group (one medal for one participant).</p> <p>10 best women swimmers and 10 best men swimmers will be awarded with prizes. Best swimmers will be found out by counting together two event points by using DSV Master Performance Table.</p> <p>Three (3) best teams in terms of team total scoring will be awarded with the main competition prize - Amber Cup:</p> <ul style="list-style-type: none"> ○ The 1st place – a big cup ○ The 2nd place – a cup ○ The 3rd place – a cup

Personal data	<p>The controller of personal data, including accreditation data, is PK “KOBRAS”;</p> <p>Legal basis for the processing of personal data - data processing is necessary for the controller to perform the duties specified in regulatory enactments, especially the Sports Law, and in these Regulations;</p> <p>The purpose of personal data processing is the registration of persons involved in the championship, accreditation, registration and analysis of the performed activities and achieved results, registration of the use of material values, as well as popularization and media coverage of the championship;</p> <p>During the “AMBER CUP” Championship, a photo and video recording of the event and its participants will be made and published (including, but not limited to, live broadcast, storage of photo and video materials in the public access archive and re-use of these materials), transferring such rights to LPF selected partners;</p> <p>Data on the number of participants in “AMBER CUP” Championship, regional and educational affiliation, as well as sports achievements will be published in both aggregated and detailed form;</p> <p>Personal data will be received by PK “KOBRAS” employees and its partners - to the extent necessary for the performance of the duties assigned to them;</p> <p>Personal data will be stored in accordance with the procedures specified in regulatory enactments until the expiry of the term specified therein;</p> <p>Participants have the right to request access to their personal data from the controller, to correct or delete incorrect or outdated data, object to the processing of their personal data (personal data processing is necessary to ensure participation in the “The RIGAS AMBER CUP” Championship, therefore termination of personal data processing will also terminate such participation), to transfer their personal data, as well as, in case they consider that their personal data is being processed illegally, to file a complaint with the State Data Inspectorate.</p>
Actual	<p>During the competition, a photo and video recording of the event and its participants will be made. The organizers have the right to use the photos and video materials taken during the competition for marketing and advertising purposes without coordination with the people appearing in them. The organizers have the right to make changes and additions to the regulations. The organizers are not responsible for the fact that the participants are not familiar with the regulations. When registering for the competition, the participant or their authorized person agrees that they have familiarized themselves with the regulations.</p>
